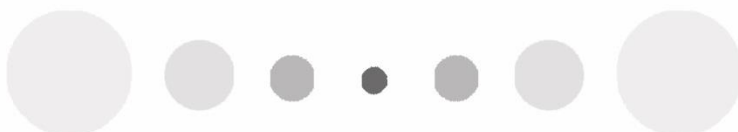
Service 3: Import/Export International Transactions

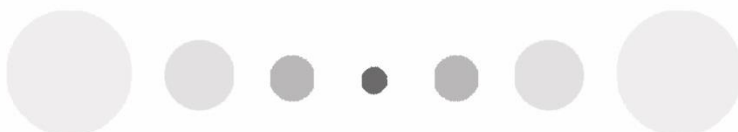
